Call to Order- The meeting was called to order by President Carolyn Kern at 10 AM

**Notice-** Notice was posted in accordance with the Association's governing documents and Florida Statutes.

**Landscaping-** Truscapes completed spraying and trimming in April. Mixed feedback has been received from residents regarding trimming. If any complaints are received, Mary Jane brings them to Truscapes attention and Truscapes has been very responsive.

**Audit-** Matt reported that the audit is still under way. Access for the last CD has been provided and authorization for access has been granted by the bank (Capital One).
